Purposes of Processing and Legal Basis

We process your personal data in connection with your participation in the “MIT einander – FÜR einander” project for housing contact mediation between students and trainees and private accommodation providers.

Personal data are processed for the following purposes:

- Registration within the project;
- Verification of eligibility requirements;
- Implementation of the matching process;
- Facilitation of contact between the parties;
- Support and documentation of the housing arrangement;
- Evaluation of the project.

The legal basis for processing is Article 6(1)(b) GDPR (pre-contractual measures and the performance of housing contact mediation services).

Where voluntary information is provided, processing is carried out on the basis of your consent pursuant to Article 6(1)(a) GDPR.

Categories of Data

Within the framework of the project, the following categories of personal data are processed in particular:

- Contact details (name, address, telephone number, e-mail address);
- Status-related data (e.g. certificate of enrolment or proof of vocational training);
- Information relating to accommodation or housing preferences;
- Information relating to requested or offered support services;
- Project-related documentation and feedback information.

The provision of these data is necessary for participation in the project. Without these data, mediation cannot take place.

Recipients of the Data

Your personal data will be processed exclusively by employees of Studentenwerk Magdeburg who are entrusted with the implementation of the project.

Your data will only be disclosed to the respective other party within the framework of the contact mediation process and with your consent.

No transfer of personal data to third countries shall take place.

Retention Period

Your personal data will be stored only for as long as is necessary for the implementation of the project.

If no successful placement is achieved, the data will generally be deleted after six months, provided that no statutory retention obligations require otherwise.

In all other respects, data will be retained in accordance with applicable statutory retention periods.

Rights of Data Subjects

Subject to the applicable legal requirements, you are entitled to the following rights under Articles 15–22 GDPR:

- Right of access;
- Right to rectification;
- Right to erasure;
- Right to restriction of processing;
- Right to object;
- Right to data portability.

Pursuant to Article 77 GDPR, you also have the right to lodge a complaint with the competent supervisory authority if you believe that the processing of your personal data violates applicable legal provisions.
